The remaining amount is due before the shipping or handover of the kitten. The kitten is accompanied by TICA US documents (blue slip) EU-passport, Chip.and Vaccinations: RCP feline + chlamydia and rabies and health certificate.

**Handover- date:** from the valid anti-rabies vaccination: \_\_\_\_\_

1. At the time of the handover of an animal that may be used for breeding, it is deemed suitable on the basis of its type and characteristics. No guarantee can be provided for ongoing development, final size and overall impression after the end of the growth period nor for fertility.
2. The Purchaser is recommended to have a veterinary practitioner examine the health of the animal within five days of the handover. In addition, no guarantee can be provided. Also excluded are diseases resulting from nutrition, such as diarrhoea and vomiting, as well as any kind of injury or disease caused by the negligence of the new owner.
3. In the event the above cat is found to have an inherited disease during the legal warranty period or the animal dies, a replacement in the form of an equivalent animal shall be provided where possible, or the purchase price shall be refunded. In the case of a minor genetic disease, a price reduction shall be granted.
4. Surgery or therapy costs as a result of a proven genetic disease shall be assumed up to a maximum amount of the purchase price and in place of a replacement animal.
5. In case of any complaints, the Purchaser has to furnish veterinary evidence or pathological evidence in the event of the animal's death.
6. If the guaranteed animal cannot be handed over for reasons attributable only to the Breeder, a different equivalent animal shall be provided where possible or the advance payment refunded.
7. In the event the Purchaser withdraws from the purchase, 50% of the advance payment shall be retained.
8. In the event the animal is not collected at the latest within 2 weeks after the agreed date, the contract is deemed devoid of purpose and the advance payment is forfeited.
9. The animal remains the property of the Breeder until payment in full.
